LOCAL NEWS 73% of female journalists face online violence

ormer President of the Sierra Leone Association of Journalists (SLAJ), Umaru Fofanah, has disclosed that 73% of female journalists globally face online violence during the course of their work.

Speaking at a training organised by SLAJ for the safety and security of female journalists, Fofanah said most times women shy away from exposing perpetuators after such intimidations and violence due to fear.

"73% of women journalists face online violence whilst working as journalists, 25 have received sexual abuse threats, 18% have received threats of sexual violence, 20% receive offline violence in connection with the online violence and 26% impact on mental health, 41% have been targeted online and disinformation campaigns, 25% have reported violence by their employers," he said.

He said female journalists are scared away and deprived of doing their work and reporting the truth online. He emphasised the need for female journalists to understand the situation before they report to avoid violence or harassment.

He underscored the importance of female journalists being thought on safety in Sierra Leone as other countries have been ahead of that.

He noted that while all journalists are in danger, female journalists are in more danger because they face threats in different forms including their lives, sexual harassment, assaults and even threat to their family members.

He said nobody likes to be exposed negatively, but that journalists

across the world are not safe since they report on issues relating to government officials and wrongs taking place in other offices.

He, however, noted that no story is worth dying for as journalists and that even though they might need the stories but should tread with caution and not endanger themselves.

Speaking on behalf the President of SLAJ, Mohamed Konneh disclosed that the training was done through a grant given by the Irish Aid to a consortium in order to expand the democratic space in Sierra Leone and ensure media capacity building to promote peaceful elections and women participation.

He said SLAJ wanted to make sure that journalists are safe during the electioneering process, more especially female journalists.

He said barely some days to the elections, journalists should come together to ensure a peaceful electioneering process for the democratic rights of all.

He said the project is being implemented at a time when the country is seeing an increase in tensions influenced by hate speech and lot of messages on the social media and the issue of fake news, misinformation and disinformation.

Sierra Leone: First female wins Chinese Bridge competition

Conteh described her winning as exciting, saying she never thought she could do it. "The feeling is just very exciting. At first I thought I couldn't do it. But with the help of my teachers and continuous study and perseverance, I made it.

he Environment Protection Agency (EPA) has used its commemoration of World Environment Day 2023, to officially end its plastic wastes collection that started Tuesday 6th June 2023. The at the Tourist Board, Aberdeen in Freetown.

Delivering his remarks on behalf of the Minister of Environment, Acting Director, Environmental Quality Control and Management, Edwin Baimba, commended EPA for organizing such an exercise, an exercise of plastic waste collection that will help raise awareness on the hazards of plastic pollution in the country.

Director Baimba stated that plastic is one of the most popular resources in the modern world, adding that it is cheap, easy to produce, durable and light.

He added that most of the plastic ever produced globally are designed to be thrown away after being used only once, which results in single-use disposable plastics waste accumulation.

"According to UNEP's report, only nine percent of the nine billion tonnes has been recycled, most ends up in landfills, dumps, or in the open plastic pollution. environment. These plastics have





Troubles in Senegal: Amnesty speaks of 23 dead and calls for an investigation

mnesty International said on Thursday it had not identified as part of the security forces for law Senegal last week, more than the official toll of the authorities, and demanded an independent investigation

Senegal was plagued from June 1 to 3 with its worst troubles for years after the condemnation of opponent Ousmane Sonko to two years in prison in a sex scandal. The announcement of the sentence sparked violence which officially claimed 16 lives.

The court decision makes, in the current state, previously justified the use of force by the need to ineligible for the presidential election of February 2024 a personality popular in youth and underprivileged circles

Through 18 interviews, authenticated videos and death certificates and autopsy reports attesting to gunshot wounds. Amnesty gives an increasing human toll and denounces excessive use of force as well as attacks on the freedom of expression and information.

"Almost 23 dead, according to our figures, including several by bullets, were recorded between Dakar and Ziguinchor" (south), Amnesty said in a press release. Three were minors, the NGO said.

Bassirou Sarr, 31, in Dakar, Fallou Sall, 25, and Ousmane Badio, 17, all three died as a result of gunshots, reveal testimonies from their relatives collected by Amnesty.

Equatorial Guinea: WHO declares end to Marburg virus outbreak

ne UN's health agency on Thursday declared an end to a nearly four-month outbreak of Marburg virus in Equatorial Guinea, saying the disease, a cousin of Ebola, had caused 35 confirmed or suspected deaths.

The outbreak of Marburg Virus Disease in Equatorial Guinea ended today with no new cases reported over the past 42 days after the last patient was discharged from treatment," the World Health Organization (WHO) said in a statement.

The highly virulent microbe causes severe fever, often accompanied by bleeding and organ failure.

It is part of the so-called filovirus family that includes Ebola haemorrhagic fever, which has caused several deadly epidemics in western and central Africa.

The outbreak, declared on February 13, was the first of its kind in Equatorial Guinea, a small coastal state in central-western Africa.

"A total of 17 laboratory-confirmed cases and 12 deaths were recorded. All the 23 probable cases reported died," the WHO said.

Four patients recovered from the virus and have been enrolled in a survivors programme to receive psychosocial and other post-recovery support," it

The outbreak in Equatorial Guinea coincided with that on the other side of the continent, in Tanzania. Six people died in a two-month episode, which was formally declared over on June 2.

The first outbreak of Marburg in Africa was recorded in South Africa in 1975.

Outbreaks or sporadic cases have been also reported in Kenya, Angola, Ghana, Guinea, the Democratic Republic of the Congo and Uganda, as well as Equatorial Guinea and Tanzania this year.

The suspected natural source of the virus is the African fruit bat, which carries the pathogen but does not fall sick from it.

Fatality rates in confirmed cases have ranged from 24 percent to 88 percent in previous outbreaks, depending on the virus strain and case management. according to WHO.

There are currently no vaccines or antiviral treatments, but potential treatments, including blood products, immune therapies and drug therapies, as well as early candidate vaccines, are being evaluated.

The virus takes its name from the German city of Marburg, where it was first identified in 1967, in a lab and support by partner organizations for the "hard where workers had been in contact with infected

In Uganda, the repression of civil society, lawyers and activists has increased in recent years, according to many human rights organisations.

According to the Ministry of Health, Uganda has officially recorded 170,255 cases of coronavirus infection and 3,632 deaths since the start of the pandemic in 2020.

Ethiopia: WFP and USAID suspend part of their food aid

Program (WFP) announced on Friday that it was in turn suspending part of its food aid to Ethiopia due to diversions, the day after a similar announcement by the American government.

"We will temporarily cease food aid in Ethiopia, but nutritional assistance to children, pregnant and lactating women, school meals programs and activities to strengthen farmers and herders* in the face of external shocks will continue without interruption, indicates the PAM in a press release.

"Diversion of food is absolutely unacceptable

WFP executive director Cindy McCain said in the text, welcoming "the Ethiopian government's commitment to investigate and hold those responsible accountable.

On Thursday, USAID , the US government's international aid agency, announced the suspension of its food aid to Ethiopia, denouncing a "widespread and coordinated operation to divert" this aid.

USAID "intends to immediately resume food aid as soon as we have confidence in the integrity of the distribution systems to get aid to its intended recipients," the agency said.

Kenya: Nairobi's national park faces climate and human threats

airobi is known as the "Green City in the Sun", due to its pleasant climate and numerous green spaces. Situated at an attitude of 1,795 meters above sea level, the city enjoys mild temperatures throughout the year.

The bustling metropolis is also home to Nairobi National Park, a wonder that's located just outside its centre.

The park is a vast wildlife reserve that covers 117 square kilometers. It's thought to be the only park in the world that's located within a capital city.

"We are privileged as being the only city that has a natural park," says Nickson Otieno from Niko Green, a sustainability consulting firm.

"Nairobi rightfully deserves that name because we are a green city that is full of biodiversity, but this is under immense threat," he adds.

Nairobi National Park is famous for its diverse wildlife that includes lions, rhinos, giraffes, buffalos and

various species of antelope. Visitors usually go on game drives to marvel at the park's natural habitat.

But experts say Nairobi National Park is faced by a myriad of threats, including pollution, human-wildlife conflict, infrastructure development and poaching.

"Some years back, we had an incident where we had lions walking on the streets, and this is something that we have not seen for generations," says Otieno.

"That tells us actually we have to rethink how we coexist, how we develop our infrastructure while at the same time conserving the rich nature that we have had as a city," he adds.

"The biggest challenge for the park is because of the growing population on the periphery," says conservationist David Mascall.

'Today, we are talking about climate change, we are talking about the importance of clean air. Here we have an environment in the middle of the city where the air is unpolluted, living on the periphery on the southern side is paradise because you are not breathing in all the nonsense and the rubbish, the noise and all the rest of it. Very, very critical to the park," he adds.

Cities around the world are having to face up to the challenges of human-caused climate change, which fuels more extreme weather such as intense wind, rain and freezing temperatures

Many cities worldwide have promised to plant more carbon-absorbing trees to help fight climate change. Research has shown the shade of mature trees also helps reduce unhealthy "heat islands," especially in





The decision was reached at a national consultation meeting held at Mile 91 Town, Tonkolili District, on Saturday, 18th March 2023, as part of the efforts to meet the current inflation rates and other statutory obligations in the country.

This decision will enhance quality in service delivery and sustainability in the operations of radio stations across the country.

It should be recalled that this is the only increment in commercials announced by radio stations in 12 years.

The Association therefore craves the understanding and patronage of the public.

The new commercial quotation which will take effect on 1st May 2023 shall be as follow:
