t is early days yet to find out if this new government will take the private sector rhetoric beyond mere platitudes and move into meaningful action. Many Ministers fail to embrace the private sector, finance to support the private sector in only to return to a vacuous sector when they leave office. finance and provide basic infrastructure to improve the ease of doing business."

Private investment in Sierra Leone however remains low. It is constrained by a cumbersome regulatory environment, administrative barriers, unstable macroeconomic environment, weak infrastructure, limited access to finance, unskilled labour and corruption. Despite our optimism and the effort of government, Sierra Leone is still a high tax country and the poor state of infrastructure is still a huge barrier to growth.

The Tejan Kabbah government, cognisant of the failures and inefficiencies of the public sector, realized the need to have the private sector play a leading role in the revitalization of the economy and embarked upon privatizing many of the State Owned Enterprises (SOEs), with the setting up of the National Commission for Privatisation (NCP). Several decades later many of the SOEs slated for privatization are still in government hands, with No "Rebuilding the wall of Jerusalem in 52 inefficient management teams and high indebtedness. The problems of many of them are compounded by ineffective Boards and considerable interference by government in their operations.

Sadly, this is the situation into which many

figures for MDAs indicates that funds are not only grossly inadequate but may not be available in a timely manner for executing their duties. Further increases in the price of fuel, rising inflation and domestic interest rates and contingent liabilities arising from the inefficiencies of the operations of SOEs are bound to exacerbate the problem. Foreign direct investments including public private partnerships would be required to make most sectors tick including the ones on the President's priority agenda.

If this Government is to succeed, Ministers should realise and ensure that the priorities stated by the President are predominantly driven by the private sector, with government serving as an enabler and not putting bureaucratic hurdles in the path of private sector investors and operators. The private sector should drive the food production, youth employment, technological and infrastructure improvements and many other aspects of the government's priorities.

There is a danger however that many new Ministers may not realise this and may be tempted to wallow in the mistake made by some of their predecessors in shutting out the private sector. Many Ministers in previous governments never bothered to engage the private sector meaningfully. They were too preoccupied with "other issues" and could not even countenance the needs of many groups in the private sector.

review of the recent budget allocation contractors or consultants who were unfairly not considered for contracts, the contractors who either did not get paid at all or only got paid when the money was almost worthless or the private sector organisations which were facing severe constraints and had to lay off staff or the potential investors who were either too burdened with taxation or unfairly edged out because they were not "connected". When private sector players asked for an audience, they were often kept in their waiting rooms for hours on the proverbial "long bench" without addressing their problems or granting them audience. Sadly, when some of these Ministers leave office and realise they need to survive in the same private sector they had shunned, they have the big climb down of waiting to see their new replacements, who may also be inclined to carry on business as usual, leave them on the "long bench".

> Ministers should bequeath an important legacy after they leave office. It behooves our new Ministers to learn from the mistakes of some of their predecessors and leave a good legacy-especially one of embracing private sector growth. I am encouraged by the fact that many of the young new Ministers, including the Chief Minister seem refreshingly open and ready to engage! They have not professed to be able to turn water into wine. May the "long bench" not be their portion in future!

> My advice to new Ministers? Embrace the private sector and behold the "long bench". Ponder my thoughts.



Climate action: Africa's ambition is to produce electric vehicles

he Acting Executive Secretary of the United Nations Economic Commission for Africa, Mr. Antonio Pedro, attended the High-Level Political Forum at the UN headquarters in New York in July. The forum focused on post-pandemic recovery and the implementation of the 2030 Agenda for Sustainable Development Goals (SDGs). Africa Renewal's Kingsley Ighobor interviewed Mr. Pedro on various aspects of Africa's development.

In Part 1 of the interview, Mr. Pedro discussed strategies to expedite SDG implementation, green industrialization and the vast potential of solar energy and electric vehicle battery precursors on the continent. These are excerpts from the interview:

Many countries are lagging in meeting SDG targets. How can African countries bridge the gap and achieve SDG targets given the current challenges they face?

Well, every country is off track. But we [Africa] are equally saying that there are opportunities to achieve the SDGs and realise Africa's Agenda 2063. Africa possesses abundant natural resources whose value could significantly contribute to the transitions that are key to accomplishing both agendas while advancing towards net-zero climate targets.

We have the African Continental Free Trade Area agreement (AfCFTA), billion people.

The ambition, of course, is to produce electric vehicles on the continent, tapping into a global market projected to be \$7.7 trillion by 2025 and \$46 trillion by 2050. Our multilateral development banks are supporting this initiative through the DRC- Zambia transboundary Special Economic Zone.

Within this zone, there is a plan to establish battery plants, solar panel plants, and other essential components, creating a complete ecosystem. The batteries will enable further deployment of solar energy on the continent to power the green industrialization point mentioned

Is there a concern that the low-carbon transition in developed countries could potentially harm Least Developed Countries (LDCs), of which 33 are in Africa, due to big companies in the West gradually depending less on Africa's primary products as they shift to low-carbon practices?

The road to achieving net-zero targets is going to be resource intensive. For certain minerals, we will need 500 times more than we are currently producing.

However, we should never anchor our development trajectory on the export of raw materials. Instead, we must focus on projects like the one in DRC and Zambia, which, by the way, will not only benefit the DRC and Zambia, because you need other minerals to be able to have a functional battery and electric vehicle value chain.

You need graphite from Mozambique, Tanzania, and Madagascar. You need the nickel from South Africa, Botswana, and Madagascar. You need the manganese from Gabon and South Africa. You need phosphate from Morocco. You need copper from Zambia and DRC.

So, it is an African-wide regional value

Our study suggests we will need about \$500 billion of investments in transport and service infrastructure, including the acquisition of about 2 million trucks to facilitate the flow of goods and services under the AfCFTA framework.

Therefore, we've gone beyond our initial objective, which was to localize the battery precursors' value chain. Now, our ambition is to produce electric vehicles on the continent, starting with the introduction of mini-buses for our public transport systems.

If we electrify our transport systems, we'll be contributing to reducing emissions and advancing our net-zero targets. It will also reduce the continent's excessive dependence on the export of raw materials.

he Deputy Executive Secretary, Independent Commission for Peace and National Cohesion (ICPNC), Moses Margao, has highlighted steps they have taken to promoting peace and national cohesion in the country between the main opposition and the government.

The commission was established by an Act of Parliament and their primary mandate is to promote peace and national cohesion in the country.

He underscored that after the elections, they learnt about confusion among Sierra Leoneans regarding the outcome of the election.

He said the commission has outlined some of their post electoral activities by engaging different institutions for them to know how they should dialogue, reconcile some of the furies between Sierra Leoneans and how they should promote national cohesion in Sierra Leone.

Report: FGM is a leading cause of death in Africa

ccording to a research from the Universities of Birmingham and Exeter, Female Genital Mutilation (FGM) is a leading cause of death in the countries where it is practised, with over 44,000 additional women and young girls dying each

The study indicates that FGM accounts for more deaths in those countries than any cause other than enteric infections - usually resulting from consuming contaminated food or water respiratory infections, or malaria and remains legal in five of the 28 countries where it is most

Researchers are calling for FGM to be made illegal in Mali, Malawi, Chad, Sierra Leone, and Liberia, given that legal change can lead to cultural change. They also say that efforts must be stepped up to eliminate FGM in countries to lead to obstetric complications, reductions in where it is practiced.

The study went on to state that there are significant numbers of girls subjected to FGM in Benin, Burkina Faso, Cameroon, Chad, Cote D'Ivoire, Egypt, Ethiopia, Guinea, Kenya, Mali, Niger, Nigeria, Senegal, Sierra Leone, and

They discovered that a 50% increase in the number of girls undergoing FGM increases their five-year mortality rate and leads to estimated 44,320 excess deaths per year across countries where the practice takes place.

James Rockey, Co -author from the University

of Birmingham, commented that their findings showed that FGM is a leading cause of death amongst girls and young women in countries where it is practised, but lasting change requires changing attitudes towards FGM in these communities.

"There is cause for optimism, as work on noncommunicable diseases shows effective interventions are possible, but change in patriarchal attitudes often lags other societal change - an important first step would be for FGM to be made illegal in the countries where it is within the law, given that legal change can lead to cultural change," he mentioned.

Globally, over 200 million women and girls have been subjected to FGM - a practice which often happens in unsanitary conditions and without clinical supervision with consequent severe pain, bleeding, and infection. It is known sexual function, and other long-term physical health problems, as well as mental health


The World Health Organisation (WHO) estimates the aggregate cost of medical treatment for girls and women after FGM was \$1.4 billion in 2018. However, until now, there has been no systematic evidence about the role of FGM in the global epidemiology of child mortality - reflecting difficulties in measuring the practice.

A key social dimension of FGM is how it impacts on marriage, for example, the practice

influences women's marriage opportunities in Western Africa - due to patriarchal culture and institutions.

"Our research suggests that decisions about FGM may reflect trade-offs between perceived disadvantages of FGM, such as pain and

illegality, and expected benefits such reduced social sanctions and a higher bride-price people may factor in an increased risk of death as part of that calculation," added Professor



Ghana implements 10% tax on betting and lottery winnings

introduced a new measure that will see a 10% tax applied to betting and lottery winnings, effective as of Tuesday,

The Ghana Revenue Authority (GRA) has outlined that this withholding tax will be automatically deducted at the point of pay-out for all betting, games, and lottery

In cases where a game is cancelled and the player's initial stake is refunded, or if the pay-out amount is equal to or less than the staked amount, the withholding tax will not be applicable. To facilitate easy monitoring by the revenue authority, lottery operators are required to update their software to display the details of the amount staked, the winnings, and the tax withheld during pay-out.

Edward Gyambrah, Commissioner of the GRA, emphasized that this tax implementation is expected to enhance domestic tax revenue mobilization, citing Ghana's comparatively low tax-to-GDP ratio within the sub-region.

However, the new tax initiative has faced criticism. from the younger generation in Ghana, who argue that betting and lottery winnings often

serve as alternative income sources for the unemployed.

In a stern warning, revenue authorities have indicated that non-compliance with the new regulations will lead to the withdrawal of licenses for sports betting firms, lottery operators, casinos, slot machine operators, and marketing promoters.

Niger coup is doomed to "failure" - Nicolas Sarkozy

ormer French President Nicolas Sarkozy on Wednesday predicted the "certain" failure of the perpetrators of the coup in Niger, believing that it was the "long-term" maintenance of French military forces in the Sahel that provoked anti-French.

"The problem is deep and in reality insoluble because it is that of the prolonged presence of our army in our former colonies", explains the former head of state, in a river interview with Le Figaro on the occasion of the release of his new book "Le Temps des combats" (Fayard)

'As good and generous as our intentions, any mission that drags on ends up making us appear (...) as an occupying force", he adds, convinced that "the Africans themselves" will understand " the impasse into which these so-called leaders resulting from military coups are leading them*

"Their failure is certain," he warns, of the perpetrators of the July 26 coup that led to the ousting of President Mohamed Bazoum. The latter is still being held prisoner in this country where France had 1,500 soldiers actively participating with the Nigerien army in the fight against jihadist groups

Criticizing his successor at the Élysée, François Hollande, Nicolas Sarkozy sees in "maintaining our army in Mali" after the military intervention decided in 2013, "a double error" . Military "because we cannot hold a territory three times the size of France with 4,000 men" and political "as we see today".

He also criticizes the socialist president who "dropped the Libvan file", after the intervention of France - within

Economically, the relationship makes even less sense. Pretoria is under strong pressure from the US and Europe to distance itself from Moscow.

Washington is Pretoria's second-largest trading partner after Beijing, with exports of \$4.2 billion in the first half of the year, compared with just \$132 million with Moscow.

Recent accusations that Pretoria secretly supplied arms to the Kremlin have prompted Washington to threaten to exclude South Africa from a major trade pact, causing concern among businesses and

Chad: outbreak of a dengue "epidemic" in the east (health minister)

had's Ministry of Health told AFP on Wednesday that an epidemic of dengue fever had broken out in the east of the country at the beginning of August, a viral disease transmitted by a mosquito, the severe forms of which are rare but can be fatal.

"The Ministry of Public Health and Prevention informs the public of the outbreak of an epidemic of dengue fever in the health district of Abeche,"

the capital of the Ouaddaï region. around 650km east of N'Djamena, Chad's capital, said Abdermadjid Abderahim Mahamat, the Minister of Health, in a statement sent to AFP on Wednesday.

On 7 August, "samples taken and analysed confirmed the existence of the epidemic, but for the

moment we have not yet recorded any deaths", said the ministry, contacted by AFP.

Transmitted by the bite of an infected mosquito, dengue fever is a virus that is widespread in hot countries and occurs mainly in urban and semiurban areas, causing between 100 and 400 million infections every year, according to the World Health Organisation (WHO).

Dengue fever can cause high fever, headaches, nausea, vomiting, muscle pain and, in the most serious cases, haemorrhaging that can lead to




