

ender Analyst at the United Nations Development Programme (UNDP), Kadiatu Bachalle-Taylor, has noted that the Gender Equality and Women's Empowerment Act (GEWE) is a key approach to national development.

She made the above assertion on Thursday, 19th October, at the conclusion of three-day engagement with women's group from six districts, hosted by UN Women at the Atlantic Hotel, Lumley Beach Road in Freetown. She said from the inception of the project titled 'Localization and Working-Together for Peace: Repositioning Women-Focused CSOs for Sustainable Peace in Sierra Leone, 'it has always been a miracle.

"At UNDP, promoting Gender Equality and Women's Empowerment is a key approach to development and our key aim is to eradicate poverty and if we are to eradicate poverty, then there is a need for us to ensure that we support the Government of Sierra Leone to structure the governance systems and structures to ensure that we have a democratic process that all citizens enjoyed their rights which includes women and girls," she said.

She said to ensure that they have equal participation and peace in Sierra Leone which requires the efforts of both women and men and forming the coalition, they believe that it has given them the platform to have an opportunity

and space where CSOs could deliberate and discuss and see what can be done to promote peace in Sierra Leone.

She continued that people may be wondering why they only chose six districts (Bombali, Karene, Kono, Pujehun, Western Area Rural, and Western Area Urban) and that prior to the elections, they looked at areas that had semblance of conflicts, indicators or drivers that were actually emerging and those were the districts

they actually targeted in the project.

"What we were looking at during the three days engagement is just a catalytic effort and we are just supporting, so that there is this platform going forward. We believe it will be your own initiative and you will be the drivers to drive your process and you will drive your vehicle right through. If we want to promote women's participation and peace within communities, it requires you to have the stamina to discuss norms and to transform norms, and also cultural practices within communities, so I have no doubt in this coalition, that you will do it," she stated.

She ended by saying that she had no doubt in the coalition because they can achieve great gains and

great results as it's not about self, but it's about the interest of the people of Sierra Leone, as several women have shown how they've been able to actually mitigating conflict across the world including Sierra Leone.

National Director for World Vision, Sagane Thiaw, said "World Vision is a child caucus organization. Our vision for every child is life in all its fullness, our prayer for every heart is for us to make it safe for girls. Therefore, we should work together to stop all form of violence against girls and women."

Building an efficient mobile payment platform for Sierra Leone

o doubt, mobile payment is growing rapidly and expanding the space for financial inclusion in Sierra Leone. Thanks to COVID-19 and limited access to formal financial services in larger area of the country which became the driving force for Sierra Leoneans to embrace their mobile phones to make financial transactions.

Launched in 2010, the digital payment technology which allows users to send and receive money using their mobile phones, has revolutionized financial inclusion, made transaction easier and enhanced access to financial services to those previously deprived of access to formal banking system.

Sierra Leone has two mobile money systems –
Orange Money and Afrimoney operated by the
major Mobile Network Companies (MNOs).
Customers use the service by visiting agents at
the nearest kiosks, hand them physical cash to
pay their bills and transfer money.

It is less cumbersome and easy for a customer to own a mobile money account as compared to formal banking system. Opening a mobile money account only requires one to just get a sim card and register, says Robert Charles Davies, Communication Supervisor, Afrimoney.

But despite the increase growth of mobile money, payment system in the country is still predominantly cash-based.

Lack of interoperability

Lack of interoperability between Mobile Network Companies operating mobile money and limited network coverage in many parts of the country remain a dominant challenge, preventing citizens' from tapping into the benefit offered by the digital payment services.

Osman Bah is a mobile money agent in Shenge, a fishing community in the coastal area of Moyamba District, the Southern part of Sierra Leone. Bah operates with both Orange Money and Afrimoney. People often go to him to collect money sent by their relatives in cities and major towns.

The challenge Bah faces is that Africell, one of the telecom companies has the most effective network coverage in the coastal community while mobile money transactions in the community are mostly done via Orange network. But because an Orange customer cannot send money through Afrimoney, Bah said it is very challenging for him dealing with customers.

"Customers give my Orange Money line to their relatives in the city to send them money, their relatives would try to call my line, but it sometimes take days to reach me through my Orange line" he said.

"The network system is very challenging here. You have to seat in a particular location to send and receive

money. And sometimes even when you think you are at the right location, the system goes down. I try to send money to people no way. They tell you connection error," the agent added. One of Bah's frequent customers, Adama Koroma is a fish monger. She does not have a mobile money account but relies on mobile payment system in her fish business. Koroma packages 'smoked' fish and send them for sale to her sister in Freetown, who sells the fish and send her back the money through mobile payment.

"Before now, It was difficult to send my sister fish and easily get back the money. But now it is better. She send my money to the agent, I collect it there and buy another fish, she said."

However, Koroma reveals it sometimes takes longer to receive money sent through the agent due to faulty network coverage or lack of energy. "There are times when I come to collect my money, the agent would tell me he has not received it as a result of the network while my sister would have confirmed she has sent the money. Sometimes he tells me his Orange Money phone is not charged, except I have to woit."

Mobile network coverage is still ineffective in certain part of Sierra Leone. And in some parts, no network coverage is available, leaving millions of people unconnected to the digital world.

A report by the International Monetary Fund indicates that network coverage is still limited with 15 percent of Sierra Leone's population having no mobile phone signal. In the report, the country is ranked 168 out of 173 countries for quality and speed, which suggest network quality in the country remain relatively weak.

Learning from success stories in Africa

Despite increase in the use of mobile phones, the percentage of Sierra Leone's mobile money account holders is still low as compared to other African countries.

Only 19.8 percent of Sierra Leoneans have access to formal financial services in the country, including mobile money, according to a <u>publication</u> by the UN Impact for Capital Development. Whereas over 55 percent of the population in <u>Kenya</u> and <u>Ghana</u> has a mobile money account each.

And unlike Sierra Leone, mobile payment operators in those countries interoperate or allow payment transactions between more than one telecommunication service providers.

If you are in certain areas of Sierra Leone where you only have access to one network coverage, you cannot conduct any digital payment transaction as long as you are not a subscriber to the network coverage available. Lack of interoperability is limiting access to mobile payment across the country and hindering the potential of mobile payment to promote financial inclusion, as users are unable to transact with people on other networks.

Appreciating the introduction of mobile payment, Sahr Ibrahim Komba, a mobile money user recalled his current and previous struggles to send money for his relatives outside Freetown.

"Before no, it was really challenging, he said, "Sometimes the money I send through travelers to my village don't reach my relatives and sometimes it takes time to reach them. But with mobile payment, it has become better."

But Komba laments he still encounters some challenges, as Orange is the only way of sending money to his relatives. He cannot use other mobile money operators to do so. The agent in his village one works with one mobile money operator.

"Let them allow interoperability," he said. "This will receive a ripple effect. It will be easy for us and allow more people to adopt mobile payment in the country."

Awareness challenge and the trust for physical eash

Many Sierra Leoneans use mobile money mostly to transfer and receive cash, but not necessarily to save and make other digital payments. Most Sierra Leoneans with mobile money accounts prefer to cash out their money and keep it physically to having it in their phones.

"One of our major challenges has to do with Knowledge about mobile money in the country as a whole. If you go to Kenya and China, the people are more knowledgeable about using mobile money," Davies said. "Getting knowledge about mobile money and getting people to get use to mobile money is a major challenge for both mobile network companies operating mobile payment in Sierra Leone."

The peoples' fear is that keeping money in a mobile phone may lead to it being lost if the phone gets missing.

In other instances, people have raised concern about receiving SMS messages from fraudsters, claiming they have won prizes from the promotions offered by the competing telecom companies. Mobile payment agents have also expressed dissatisfaction with the

slow process involved in reversing money sent to the wrong customers. These are flaws the telecom service providers have not been able to tackle.

But Mamadu K Barrie, Afrimoney operations staff said individual mobile money accounts are secure. Subscribers are at liberty to provide unique password that secure their accounts which they can change at will. And where the phone of a mobile money customer gets missing or are stolen, the cash in there can be retrieved.

But many mobile payment account holders have no knowledge on how they can personally protect their accounts, which suggest the need for more education and awareness campaigns to address digital payment literacy gap and build trust for mobile money services in the country.

"The mentality of handling physical money is still much in Sierra Leoneans. We have more to do," Barrie said. However, he argued that awareness raising alone by telecom service providers without government intervention is not enough."

'We need the Policy makers"

Barrie suggests government implement policies that would make digital payments mandatory across the country. "If parents pay school fees with mobile money, at the supermarket, you pay with mobile money, and a passenger pay a taxi driver using mobile money, it would ease the burden of government having to print money every year. Government need to drive the use of mobile money payment."

There are plans for government to introduce a digital payment system that allows interoperability among mobile payment operators, commercial banks and Point of Sale (POS) systems.

That's packaged in the National Payment Switch Bank of Sierra Leone launched in May this year. According to the Central Bank, the digital infrastructure will facilitate electronic payment in the fastest possible time and promotes financial inclusion through interaction with banks, POS, Automated Teller Machines and Mobile Payment Systems.

The switch, whether it has started working or not, is currently at its first phase, limited to only five commercial banks. Mobile payment is yet to be included.

"We haven't got interoperability. Even at the central bank, it is not available. This is the issue with telecoms and mobile money," Barrie said. "If the national switch is extended to the mobile money, it will accept moving money from one network provider to the other. Afrimoney platform is ready, but just that regulation does not allow at the moment."



Deputy Minister of Agriculture, Dr. Theresa T. Dick, has re-echoed the ministry's commitment to implementing the government big five agenda to ensure there is sufficient food to feed the nation.

She was speaking at the 2024 budget hearing conducted by the Ministry of

She called on the Finance Ministry to pay kin attention to some of the challenges the Ministry of Agriculture had been facing, including the late disbursement of funds.

She said timely disbursement of budget is very necessary, in that should they want to succeed they need to go to early work and preparations.

> He said their mission to develop, implement and adopt appropriate policies, programs and institutional management systems towards enhancing agricultural development through commercialisation and private sector promotion.

> Their vision, he said, is to make agriculture the engine of socioeconomic growth and development towards achieving food security, employment opportunities and poverty reduction.

> He noted that boosting the Feed Salone flagship programme, agriculture productivity will fuel inclusive growth, increase local food

production and reduce dependence on food import, reduce hunger, increase export earnings, create jobs, and build resilience.

He presented that their strategic objectives is to import substitution of key staple food, adding that Sierra Leone should grow enough to feed itself in the immediate term.

He disclosed that the country imports annually over \$500 million of various food items and that the key objective of the Feed Salone programme is to gradually reduce such amount in the next five years.

He said they will increase local production in key value chains such as rice, poultry products (eggs and chicken), onions, vegetable oils, and dairy products, to reduce their importation.

He said they would boost export earnings from agriculture and that agriculture must be a source of significant foreign exchange generation.

He disclosed that the sector contributes 57.5% to the GDP in 2022 and that the total GDP at Market Price in 2022 was SLL48, 909,104 with the agriculture sector contributing SLL 28,100,880.

He said in the next five years, they will boost export earnings from agriculture through enhanced productivity in key cash crops such as cacao, coffee, palm oil and cashew food exports.

He said they wanted to reduce hunger and malnutrition because according to the World Food Programme (WFP), Sierra Leone continues to have unacceptably high rate of food insecurity and malnutrition.

He said over one million people are considered chronically hungry and the local food system must be part of the solution to reducing chronic hunger and malnutrition, especially in rural communities.

He said they will strengthen the link between food production, nutrition, and health and value chains.

He said the Feed Salone Program will help to address access to finance challenges for both smallholders and large-scale farmers and that it also aims to de-risk private sector investment in the agriculture sector and will encompass insurance schemes to protect farmers against weather shocks, credit facilities designed to fit the production cycles, minimum price guarantee schemes and matching grants for farmers that want to expand production.

EU-SIERRA LEONE POLITICAL DIALOGUE JOINT PRESS RELEASE

Freetown, 17 October, 2023

The 2023 annual Political Dialogue between the Government of the Republic of Sierra Leone and the European Union (EU), chaired by H.E. Rtd. Brigadier General Julius Maada Bio, President of the Republic of Sierra Leone, took place at State House in Freetown on 17 October 2023, where issues of mutual interest were discussed and advanced.

The dialogue started with an exchange on the economic situation in Sierra Leone. As in previous years, Team Europe and representatives of European private sector companies operating in Sierra Leone had fruitful engagement with H.E. President Bio on the conditions for creating an enabling business environment.

The dialogue also included an exchange on the support of Team Europe (European Union and its Member States) to Sierra Leonean initiatives for the development of the country. The priorities of the ongoing cooperation between Team Europe and Sierra Leone will contribute to the implementation of the Government's "Big 5" Priority National Development Agenda, mainly in the areas of food security, green economy, human capital development and governance.

With regard to the importance of multilateralism, both sides underlined their commitment to a rules-based world order within the framework of the United Nations. The Government of Sierra Leone gave an update on their priorities for their upcoming non-permanent membership of the United Nations Security Council 2024-2025. Background

The Government of Sierra Leone with support from the International Development Association (IDA) of the World Bank is implementing the Sierra Leone Land Administration Project (SLLAP), financed through a US\$ 41.1 million grant. The proposed Project Development Objective (PDO) is to establish an efficient and accessible land administration system.

The SLLAP will be implementing those parts of the National Land Policy 2015 (NLP) that relate to Land Administration. Currently land in the Provinces is administered through various customary tenure arrangements and land in the Western Area has a system that includes freehold tenure under Statutory Law as seen in most formal systems around the world. In the Western Area, the existing systems rely on a system of registration of instruments (or deeds) at the Office of the Administration and Registrar General (OARG) overseen by the Attorney General under the Ministry of Justice, with boundaries documented through a Cadastral Survey methodology described in the Land Survey Act and administered by the Director of Surveys and Lands within the Ministry of Lands, Housing and Country Planning (MLHCP). In 2022, the National Land Commission Act and the Customary Land Rights Act were passed, and they will be implemented with support from the project. The development of a new law that will introduce a Land Title Registration system is included within the NLP, but this has not yet been drafted.

SLLAP will support real estate land property markets for both the private and public sectors. It will assist the work of real estate agents, notaries, licensed surveyors, and lawyers and help build the private sector in these disciplines. It will improve the transparency and security of property rights, which will help address the use of real estate in Sierra Leone and its use for collateral and mortgage purpose. It will speed-up the real estate transaction processes and aim to reduce transaction costs as well as protecting property rights of vulnerable groups, women, and customary communities. Another focus is to improve the efficiency of state property management and would continue supporting the various real estate privatization programs in the country. Many of these goals would be supported by making real estate market information accessible through information technology and linkage with e-Government initiatives.

Following years of civil turmoil between 1991 and 2002, much of the capacity to manage the land administration system was significantly reduced, with particular impact on the cadastral surveying profession, which is now particularly in need of modernizing and bringing up to professional standards.

The PDO will be delivered through the following project components:

Component 1: Institutional Development and Legal Reform: This component seeks to strengthen Sierra Leone's institutional framework for land administration by supporting the establishment of the National Lands Commission (NLC). The project will support the funding required for office building or renovations (both at the headquarter and district level), organizational development plans and strategies, operational support (vehicles, furniture, equipment), capacity building, assessments, drafting and consultations for relevant land policies, laws, and regulations and public awareness raising.

Component 2: Land Information System: The component supports the overall development of a digital land information system (LIS) in Sierra Leone. The project will finance the required ICT equipment (servers, computers, internet etc.), design and development of a digital LIS with automated land administration processes (which need to be reviewed and simplified); the digitization of land records and cadastral maps and base mapping; and the establishment of a geodetic network.

Component 3: Recording and Registration of Land Tenure Rights

The primary focus of this component is to improve the quality and completeness of the records of land tenure rights and the ease and security with which those rights can be transferred whether by inheritance, sale or lease, or for some other third-party rights. The component will finance survey and registration work in customary areas and linking deeds records and maps in the Western Area.

Component 4: Project Management

This component will finance all expenses required to ensure efficient and transparent project management and coordination. This will entail in particular the financing of hiring of staff for Project Coordination Unit (PCU), operational costs (vehicles, fuel, equipment, workshops, etc.), M&E studies (customer surveys, mid-term review, implementation and completion report), and safeguards studies (social and environmental).

Component 5: Contingent Emergency Response Component (CERC): Zero-sum component to mitigate situations of urgent need and allow for the rapid reallocation of funding in the event of a natural disaster or crisis

Objective of the Assignment

After that, I will enjoy the holidays in Argentina. It's the first time that I am going to have more days off in December, with the holidays, with peace of mind, with my



Palestinian officials say the horror explosion was caused by an Israeli Defence Forces (IDF) air strike, while officials in the Jewish state insisted it was the result of a 'failed' rocket launched by terrorist group Islamic Jihad.

Reports in Salah's native Egypt earlier this week suggesting he had donated a significant but undisclosed fee to the Red Crescent via agent Ramy Abbas to help innocent civilians in the area receive aid.

Salah recorded a monologue issuing a call for world leaders to help 'prevent' any further loss of life and to stop families being 'torn apart'.

'It's not always easy to speak at a time like this. There has been too much violence and brutality, the escalation in recent weeks has been unbearable to witness,' began the Egyptian's powerful message.

All lives are sacred and must be protected. The massacres need to stop, families are being torn

'What's clear now is that humanitarian aid to

Gaza must be allowed immediately. The people there are in terrible conditions. The scenes at the hospital last night were horrifying.

'The people of Gaza need food, water and medical supplies urgently. I am calling on world leaders to come together and prevent the slaughter of innocent souls. Humanity must

Humanitarian aid is currently blocked from entering Gaza - as its residents are blocked from escaping - at the Israeli and Egyptian borders, limiting the ability of aid organisations to bring relief following a fortnight under siege for its residents.

Salah becomes the most high-profile Premier League footballer to speak out about the ongoing conflict. The Palestinian health ministry says at least 4,000 people have been killed and many more injured in the Gaza strip since fighting broke out two weeks ago.

The Egyptian and team-mates will join all Premier League players in wearing black armbands this weekend as the Premier League will pay respect to the innocent loss of life in Israel and Gaza.

'The Premier League is shocked and saddened by the escalating crisis in Israel and Gaza,' read a statement this week. 'And strongly condemns the horrific and brutal acts of violence against innocent civilians.
